

**ALGER COUNTY BOARD OF COMMISSIONERS  
REGULAR MEETING**

**December 17, 2018**

**Minutes are subject to corrections and approval**

Pursuant to recess, the Alger County Board of Commissioners convened in the conference room of the county building at 4:00 p.m. on the above date.

The meeting was called to order by Chairman Doucette with the following Commissioners present: Commissioners Mattson, Pullen, Rondeau, VanLandschoot and Doucette. Absent – None.

The board of commissioners said the Pledge of Allegiance.

Public comment session was open. Dulcee Ranta updated the Board regarding the status on the Alger County Equalization Corrective Action Plan. Steve Webber commented that Mrs. Ranta has met all expectations and thanked her. There was no further public comment; thus, the public comment was closed.

It was moved by Commissioner Pullen and seconded by Commissioner Mattson approve the consent agenda which includes the following items:

Affirm Approval of Flexible Spending Account (\$2,650 annual max / \$500 rollover);

Affirm Approval of payment for 2019 CUPPAD Membership Dues of \$4,500;

Affirm Appointment of Mickey Rondeau to the 2019 UP State Fair Authority;

Affirm Nomination of Jerry Doucette to the 2019 UPCAP Board;

Authorize payment of Board Bills;

Approve financial reports for all funds (Trial Balance Report Available). A full 30-page report is available upon request with the treasurer;

Authorize the clerk to transfer \$4,353.83 from Treasurer (101-253) to Administrator (101-172);

Authorize the clerk to transfer \$594.33 from Treasurer (101-253) to Park Patrol (101-303);

Authorize the clerk to transfer \$4,101.10 from Treasurer (101-253) to Airport (101-536);

Authorize the clerk to transfer \$28,681.02 from Treasurer (101-253) to Bond Payment (101-706);

Adam Simonsen and Brian Coleman from Compudyne were present to update the Board of Commissioners regarding I.T. services provided for Alger County. There have been problems recently with critical I.T. infrastructure such as LEIN and LIVESCAN. The State of Michigan was responsible for the delays. Other issues were addressed such as onsite visits, tickets submitted online, backup to retrieve lost data. The backup service will be upgraded to include all data, not just shadow copies.

It was moved by Commissioner Pullen and seconded by Commissioner Mattson to approve the 2019 General Fund Budgets in the amount of \$4,300,159.96.
