Dave VanHaaren, AKT Peerless – Environmental Services, gave an update to the Authority of the tasks for our current project at Lammi's (Chatham Corner Store):

Task 1 - Addressing MDEQ 2012 site investigation recommendations

- Further site investigation at the property to evaluate subsurface soil and groundwater related to potential subsurface soil gas vapor.
 - $\underline{Task\ 2}$ Developing strategies for funding Incentives and redeveloping the subject property, including project meetings
- Identify available Brownfield redevelopment funding sources and incentives that may be applicable to the project
- Develop a Preliminary Financing Plan to outline future steps supporting the reuse/redevelopment
 - Task 3 Conduct a Property Condition Assessment of the Subject Property
- To evaluate the condition of structures on the property
- Provide an independent, professional opinion of physical deficiencies observed at the property. The term physical deficiencies as defined by ASTM means the presence of conspicuous defects or material deferred maintenance of a subject property's material systems, components, or equipment as observed during the field observer's walk-through survey.

Gabriel Zawadzki, MAC – Grant Services Program, explained to the Authority that the EPA grant was not successful this year and a debriefing conference call was held to find out what weakness was in

the grant application. The grant application score will be made as part of the minutes.

Dave VanHaaran also thought that it would be a good idea to get with TAB-BIT, to compile an inventory of Alger Brownfield sites. The Brownfield Inventory Tool (BIT) is a comprehensive brownfield program management tool. We may enter detailed site data, upload documents and data, generate and export a variety of reports, including a property profile form. MaryAnn Froberg make a motion and seconded by Esley Mattson to have a conference call set up with TAB-Bit and have Alger County properties compiled. Motion carried.
